Standard Conditions of Hire:

1. **Right of Access:** The hirer shall not have access to the clubrooms on Sunday, or earlier than 5.00pm Monday to Friday unless stated through prior permission. Access for set up can be arranged through prior discussion.
2. **Food and Beverage:** Only food and beverage purchased from the Club may be consumed on the premises. The Club reserves the right to refuse to sell liquor in accordance with the requirements on the Sale of Liquor Act 2012.
- 3 **Payment** of Clubroom hire is due at the time of booking. Bar service and Catering/Food or other charges are due on the night/ after the hire period.
4. **Limitation of Liability:** The Club accepts no liability for any charges associated with the hire of any equipment, or glass ware, which it may arrange on behalf of the Hirer, nor does it accept liability for loss or damage to property or injury to persons associated with the hirer while on the Club's property during the period of hire regardless of cause.
5. **Indemnity:** The Hirer will indemnify the Club against all claims arising from loss or damage to the property or injury to persons associated with the Hirer and will provide a bond of up to \$500, in advance of the period of hire, in addition to the prepayments noted in clause 3, at the request of the Club Manager.
- 6: **Access to Golf Course:** Unless the hire is associated with a golfing activity then access to the golf course is not permitted at any time.
- 7.**Cancellation:** Bookings may be cancelled up to 30 Days before the time of hire, with a 50% refund of any prepayments. No refund due if cancelled later than 30 days prior to event,
8. **Completion of Hire:** The hirer is responsible for the removal of any special decorations immediately upon completion of hire and restoring the hired area to a satisfactory condition. In the event this is not done the Club has the right to remove and dispose of such decorations and the Hirer will be responsible for any costs associated with this.
