Our clubhouse caters for events ranging in size from a boardroom meeting of 10 through to a full golf day up to 140, weddings to 120 or a cocktail function or product launch up to 200. Remuera Golf Club caters for a wide variety of golf events that can be tailored to suit your needs and budget from a minimum of 4 players through to full course exclusivity up to 120.

We understand that your event is held to assist in the promotion of your organisation to your clients and it is our intention to do our best to assist you in this regard. Should you have any promotional signage or products you would like to display, our staff are happy to discuss placement and utilisation of them with the most exposure available for your company.

## **Wet Weather**

Our guarantee to you is that should the course become unplayable due to heavy rain or is dangerous due to lightning, you will have the option to reschedule your event (where available) or receive a full refund of deposit. However, as golf can be played in inclement conditions, this guarantee won't apply if the weather is merely unpleasant.

## **Holes in One**

We are happy to assist with organising a Hole in One prize for your day, including Hole statistics, Hole in One history and procurement of insurance quotes and monitoring for the event.

## **Dress Code**

Remuera Golf Club requires a high standard of dress at all times. Smart casual golf attire must be worn on the course and soft spiked golf shoes mandatory. Not permitted on the course are Jeans, Football Jerseys, Tracksuits or Beachwear. Mobile phones on the course are not encouraged but if necessary, players should first seek approval for surrounding others or isolate themselves from the group.

## **Golf Event Prices**

The typical green fee at Remuera Golf Club is \$100.00 with Course exclusivity able to be guaranteed if you have more than 80 players at a cost of \$6,000.00.

This consists of a 12.30pm Shotgun Start with Course exclusivity through until 5.30pm

Should your group consist of less than 80 players, the course will be open to other Club Members or another group booking.

Golf Carts are available at \$50.00 – Maximum 24

Trundlers are available at \$5.00 – Maximum 15

Golf Club Hire available from \$65.00 – Maximum 8

Golf Clinics or coaching can be arranged prior to your event

## **Food and Beverage**

All food and beverage requirements both on and off course, **must** be purchased from Remuera Golf Club and will be charged accordingly. Catering numbers will be confirmed at least 10 days prior to the event and will be charged the higher of either the confirmed number or the number attending on the day.

We are a fully licensed premise with full range of Food and Beverage facilities available and as required through Liquor Licensing Legislation, we are unable to allow, **at any time**, alcoholic beverages to be bought onto our premises for consumption.

## **Conduct**

The host is responsible for the general conduct of guests whilst on the premise of Remuera Golf Club and will comply with the Club's Host Responsibility Policy. Remuera Golf Club Manager on Duty reserves the right to eject any person from the premises should their conduct be deemed unreasonable or not in accordance with the Club's policies or procedures.

## **Clubhouse or Course Damage**

The organiser is financially responsible for the cost of any damage sustained to the course or clubhouse by any person involved with the event, outside of the perimeters of normal usage wear and tear, with the exclusion of Remuera Golf Club staff.

The Remuera Golf Club and/or Employees will not be liable for any loss or damage to any property left by the host or guests on the premise during or after the event.

## **Deposit and Cancellation Policy**

### ***Bookings*** –

All Event quotes will remain valid for 30 days from the date of the quotation and are quoted inclusive of GST.

Tentative bookings will be held for a period of 14 days, after which time the date will become generally available for other potential bookings.

To confirm your event, Remuera Golf Club requires a deposit of \$3000.00 along with the signed terms and conditions. This deposit will be deducted from the overall cost of your event.

Anticipated numbers attending must be confirmed no later than 10 days prior to the date of your event and will be the minimum charged for the event. An allowance of 10% above this number may be accommodated where possible.

### ***Final Payment*** –

Final payment (less deposit) for all events will be required no later than 7 days after the event has been held.

### ***Cancellations*** –

In the event of bad weather, where Remuera Golf Club closes the course or declares the course unfit for play, the deposit will be returned to the client conducting the day. Catering arrangements may continue at the discretion of the client or the client may cancel catering only where the club has closed the course without penalty.

In the event the client requires cancellation of the event, the following cancellation charges will apply;

Cancellation within 61-90 days of event – Initial deposit of \$3000.00

Cancellation within 46-60 days of event – Initial deposit of \$3000.00 plus 25% of event total projected cost

Cancellation within 31-45 days of event – Initial deposit of \$3000.00 plus 50% of event total projected cost

Cancellation within 30 days of event – Initial deposit of \$3000.00 plus 75% of event total projected cost
